RV Rental Contract

Reservations/Deposits/Cancellations

Reservation Application & Terms and Conditions signature page must be filled out in its entirety. Upon receipt of application, a \$250 reservation deposit will be collected. No reservations can be held without receipt of the deposit. Reservations are on a first come first serve basis. The balance of the rental fee must be paid 1 week prior to departure. ****All cancellations received 8-30 days prior to departure will be assessed a \$100 cancellation fee and total loss of deposit when less than 7 days.**

Security Deposit

A \$500.00 security deposit is required at time of rental and will be refunded within 14 (fourteen) days after RV is returned, as long as, unit is returned clean, holding tanks are emptied, and no damage was done to the unit. Damages, additional charges or disputes may further delay deposit refund. Deposit may be made by credit card or cash. However, a valid, signed credit card authorization is required to be on file. At the time of vehicle return, in the event of vehicle damage, an additional security deposit of up to \$2,000.00 may be charged and used to remedy all repairs that are required to have the vehicle fixed and in normal operating condition. This includes, but is not limited to, out of service charges. Lessee is responsible for 100% of all damage and costs to the rented unit.

Service Calls

Customers are provided an emergency telephone number. In cases where a service call is required due to inappropriate use by customer of a unit's mechanical features, a service call fee will be charged at the rate of \$70/hour with a 1 hour minimum, including travel time.

Payment Terms

Full payment of rental contract is due 7 days prior to departure and may be made with credit card or cash. Personal and company checks must be approved prior to departure. No refunds on early returns. Major credit cards accepted: *Visa, MasterCard, American Express, and Discover.*

Age Requirements

All renters must be 25 (Twenty-Five) years of age or older, have a valid driver's license and proof of insurance.

Availability

Bonner Sports & RV ability to provide a rental unit is contingent upon and subject to its return by the previous renters and to have no accidents or other causes beyond the Company's control. If, for any reason beyond the Company's control, the unit reserved is not available, the Company reserves the right to substitute another unit. Should another unit not be available, the Company's liability will be limited to the refund of all refundable monies paid by lessee (the deposit).

Insurance / Liability

Lessee is responsible for all damages and costs to RV, including tires. Report all accidents to Bonner Sports & RV and police immediately. Should a breakdown occur, lessee must notify Bonner Sports & RV for repair authorization and follow instructions provided by Bonner Sports & RV. The customer is responsible for reporting mechanical failures immediately. Customers may be held responsible for mechanical damage due to negligence in vehicle operation or failure to provide normal maintenance. In the event the vehicle is in breakdown repair for 12 hours or more, through no fault of the customer, our responsibility to customer is limited to refund of daily rate or portion thereof. Radio, air conditioning, refrigerator, microwave, appliances, etc are not considered breakdowns and no refunds are available for repair time to these items.

Lessee agrees to provide to Bonner Sports prior to rental a valid insurance binder from your insurance company covering "physical damage (up to replacement value) of an un-owned trailer". If your insurance does not provide this type of coverage insurance coverage must be purchased from Bonner Sports & RV.

Terms & Conditions

All provisions of our rental agreement apply to each rental. Lessee will be required to sign this agreement at time of reservation. The rental agreement is available for review at any time prior to departure. 3 days is the minimum rental period. Supplemental insurance is not offered by Bonner Sports & RV. No smoking in rented vehicles at any time. Lack of compliance may result in forfeiture of security deposit and/or a minimum charge of \$250.

Pets

There is also an additional \$100 Security Deposit that is required when bringing a pet. If evidence of a pet is found and it was NOT disclosed at the time of reservation, you will be subject to an automatic \$200 loss in your security deposit.

Check Out - Check In **

Pick-up and Return Hours: 10am to 4pm Monday - Friday

The unit will be checked out completely as to operation and condition with you and a representative before departure. Renter will receive additional information regarding the operation of the RV at time of check out. At time of check out, unit will have full propane tanks, holding tanks will be dumped, and the interior and exterior will be clean. All units are properly cleaned and disinfected after every rental. All units are provided without linens or dishes. Additional items are available such as: toilet paper, chemicals, hitches, and brake controls. (Call for pricing.)

Allow at least one (1) hour for check out.

Upon return, the unit will be inspected. The interior and exterior are to be clean and all personal belongings removed. Bonner Sports & RV will not be held responsible for items left in vehicles at time of return. Based on the condition of the rental unit at the time of return, the appropriate charges will be applied against the security deposit. In the case of damage to the unit, proper documentation will be made at time of return.

If the unit is not available for pick-up at the prearranged time an extra day rental will be charged unless prior arrangements have been made.
